

ADMINISTRATIVE ORDER 07-15


RE: Pretrial Global Positioning System (GPS) Program Changes

Pursuant to the authority vested in the Chief Judge of the Nineteenth Judicial Circuit of Florida, the following changes are made to Administrative Order 06-01:

WHEREAS, Sentencing Alternatives, Inc., a private contractor, after a thirty (30) day notice by St. Lucie County will no longer provide the GPS (global positioning satellite system) monitoring for pretrial defendants. The transition from Sentencing Alternatives, Inc. to the St. Lucie County Pretrial Program was accomplished during June 2007, and all pending defendants (whether on GPS monitoring or standard pretrial supervision) were transferred during the same transition.

The members of the Pretrial Committee will continue to meet to enhance and expand the program to meet the needs of the Courts and the Criminal Justice Community, while insuring the safety of the community, by monitoring compliance of those defendants under pretrial supervision. Until further changes of this Administrative Order are enacted, this Administrative Order will provide an interim coverage of the basic program requirements by providing that the St. Lucie County Pretrial Program will replace all notations of Sentencing Alternatives, Inc. in the original Administrative Order. All other wording in the original Administrative Order 06-01 will remain effective until further amendment, with this amendment providing the same authority to the St. Lucie County Pretrial Program to provide those same services as noted in the original Administrative Order. Additionally, the St. Lucie County Pretrial Program will only be authorized to accept cases involving individuals who reside within the Nineteenth Judicial Circuit.
